



The Finance Council Report for St. Philip Neri Parish For the Year ending December 31, 2024

The members of the Finance Council include Denis Benard, Bruce Sparling, Fr. Doug Jeffrey OMI, and myself, Bill Martin. Staff support to our Finance Council is provided by Joanne Lysyshyn, our Parish Accountant.

The annual total revenues for 2024 were \$660,620.00 and annual total expenditures were \$603,228.00. This resulted in a 2024 surplus of \$57,392.00.

Some items to note:

- 1. Weekly collections were up by 4% over the collections of 2023.
- 2. The Parish has established an annual replacement reserve fund to recognize the costs of future major replacements and repairs. We add \$24,000 to this fund each year. This year we spent \$15,764 from this fund for repairs and replacements for the Church and Rectory. That leaves \$181,755 in this **Restricted Capital Reserve**.

We thank all of those who have contributed to the General Reserve Fund which helps to pay for on going building and maintenance related expenses.

We had 603 registered families in 2024. Of these 167 families used envelopes and e transfers to donate to the Parish and 216 families used Pre-Authorized Giving to donate. We received donations from 103 persons who donated as infrequent donors or visitors. We thank all of the families who have contributed so generously to our Parish.

As we look forward to the end of March, 2025, we see weekly collections continue to increase. Expenses will increase this 2025 year since staffing has increased to accommodate the needs of the Parish.

The Finance Council members would like to sincerely thank everyone for your continued support of the Parish and all its ministries. We thank you for your donations of time, talent, and treasures during the past fiscal year and ask for your continued support as we journey through 2025.

Note 2

Parish development funds are cash term deposits in a centralized diocesan investment fund. These amounts are interest bearing deposits and can be withdrawn with notice.

Note 3

Buildings and equipment are recorded at their original cost and are not depreciated.

Note 4

The Parish has established an annual replacement reserve fund to recognize the costs of future major replacements and repairs. An annual expense of \$24,000 is recorded in the statement of operations "Property and Capital Maintenance" expense and the cumulative reserve is included in net assets. Future major replacements and repairs will be charged to the Restricted Replacement Reserve.
